Notice of Substantial Amendment to the City of Gastonia PY 2019/2020 Annual Action Plan

The City of Gastonia is proposing its first Substantial Amendment to the 2020-2024 Consolidated Plan and PY 2023-24 Annual Action Plan (AAP) to reallocate funding as received from the U.S. Department of Housing and Urban Development (HUD) through the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) Programs. The purpose of this notice is to solicit comments from City of Gastonia residents regarding the proposed Amendment. The Amendment will be available for review by the general public beginning October 7, 2023. An Amendment is necessary because the City is proposing to fund activities not previously described in prior submissions of the 2020-2024 Consolidated Plan and PY2023/2024 Annual Action Plan.
